This is the test plan and report for LDM-503-10a: (LSP with Authentication and TAP), an LSST level 2 milestone pertaining to the Data Management Subsystem.







# LDM-503-10a: LSP with Authentication and TAP Test Plan and Report

### 1 Introduction

### 1.1 Objectives

Verify the integration of federated authentication and authorization into the LSST science platform, and the availability of an IVOA TAP service.


### **Milestone Description**

This test demonstrates the successful integration of a single-sign-on federated authentication system, and a basic authorization system, with the three Aspects of the LSST Science Platform (Portal, Notebook, and API), with the API Aspect containing at least a TAP service. It will be demonstrated on a Kubernetes cluster provided by NCSA. It is not required for authorization to be applied at the database level; it is sufficient for this milestone for it to apply only at the TAP level. Data served will remain that from the original PDAC work, i.e., SDSS Stripe 82 and/or WISE.

### 1.2 Scope

The overall strategy for testing and verification within LSST Data Management is described in LDM-503.

This test plan specifically verifies successful completion of milestone LDM-503-10a.



### 1.3 System Overview

The LSST Science Platform (see LSE-319, LDM-554, and LDM-542) is the means of access for science users to the LSST data. It also serves project-internal users for a wide variety of data access needs during construction (using prototypes and early versions), commissioning, and operations.

### 1.4 Document Overview

This document was generated from Jira, obtaining the relevant information from the LVV-P48 Jira Test Plan and related Test Cycles ( LVV-C85 ).



### 4.2 Overall Assessment

The test successfully demonstrated cross-Aspect single-sign-on and the federated-identity functionality, as well as demonstrating authenticated access to synchronous and asynchronous TAP queries from the Portal Aspect, Notebook Aspect, and from outside the LSST environment acting directly on the API Aspect. The test demonstrated the ability to perform a TAP query in the Portal Aspect and retrieve the results from the Notebook Aspect, or remotely, by means of the query URL obtained from the Portal UI.


Minor issues were observed in the following areas:

- 1. "Logout" functionality was not particularly user-friendly, and in some cases may not have performed a complete logout
- 2. The CILogon federated-ID-authentication service may in some cases allow a user to determine whether a userid string is valid at NCSA even without a password
- 3. The existing set of tables in Qserv were not organized or described as well in the API Aspect TAP service's TAP\_SCHEMA interface, and therefore also not in the Portal Aspect UI however these were corrected immediately following the test under DM-22422
- 4. The WISE (including NEOWISE) single-epoch photometry tables were not visible in the TAP service this has been understood and will be addressed
- 5. The most recent version of the Python "convenience API" for TAP searches in the "jupyter-labutils" package became unusable for external queries because of an issue with token validation. A previous version supported the test successfully, and the path forward for this API will be discussed.

### 4.3 Recommended Improvements


The most salient UX improvement based on this testing would be to change the "logout" functionality in both the Notebook and Portal Aspects to return the user to the LSP landing page, or some other recognizable page, as well as to add to the landing page an indication of whether the user is logged in or not.

Ongoing attention to the quality of the information in TAP\_SCHEMA would be highly desirable.



This is more of a science-support issue than a TAP-service-development issue.

Some thought should be given to what support code, examples, and documentation should be provided for external users of the TAP service (and other API Aspect services as they become available).



### 5 Detailed Test Results

### 5.1 Test Cycle LVV-C85

### 5.1.1 Software Version/Baseline

Portal Aspect tests were carried out on suit:1.1.1 and Caltech-IPAC/firefly:release-2019.3.2. The LSST Python environment in the Notebook Aspect was based on weekly 2019\_48, including JupyterLab v1.2.3.

LSST JupyterHub version sciplat-hub-with-config:0.16.7 was in operation in the instance under test.


TAP version 1.0.1 was the version under test.

### 5.1.2 Configuration

LVV-T807, LVV-T637, and LVV-T1334 were carried on out the lsst-lsp-int instance of the LSP because of maintenance issues with the Portal Aspect on lsst-lsp-stable.

Following the return to normal operation of lsst-lsp-stable, part of LVV-T1334 was repeated there, and LVV-T1436 and LVV-T1437 were executed there.

All tests were executed from an OS X 10.11.6 iMac host on the IPAC internal network, with prearranged VPN-free access to the LSP instances at NCSA. Tests requiring a web browser were carried out using Firefox 70.0.1.







This test does not involve any exploration of the Portal behavior at this point. Test Data Credentials for the user executing the test. **Expected Result** Access to some version of the Portal interface is granted. (The exact nature of that interface will be evolving in the course of LSST construction and system integration.) Actual Result The "TAP Searches" screen of the Portal application appeared by default. Status: **Pass** Description Log out from the Portal. **Expected Result** A logout or LSP landing page is displayed. Actual Result A screen with just a "Sign in with OpenID Connect" button (and a footer reading "Secured with OAuth2 Proxy version v3.2.0-151-g151ec7b") appeared. This is not entirely acceptable in the long run. The user should never lose sight of a screen that confirms that they are still in an LSST environment. It is also not clear to what authentication domain one would be signing in, or what screen one would reach if signing in were successful. Issues found executing this step: DM-22350 "Logout" buttons in Portal and Notebook Aspects: non-user-friendly result, and apparently incomplete logout Status: Initial Pass Description



Manual navigation back to the main instance landing page was required. No link to do this was available from the screen displayed in Step 4.


Once at the landing page, clicking on the "Notebook Aspect" link produced a fresh CILogon login screen.
